Message from the Board Chair and CEO

Our Annual Report serves an important purpose – allowing us to reflect on a truly extraordinary year.

The pandemic had a major impact in all sectors, including the charitable sector. As organizations faced increased demand for services, they also struggled with decreased revenue along with staff and volunteer shortages. The increased pressure is taking a toll as we move through a fourth wave. For United Way Regina, we continue to assess risks and adapt to our changing environment. Never has the digital world been more important to our efforts than in recent months. It is essential that we adapt our processes, maximize the use of technology, diversify partnerships and effectively communicate our impact for a sustainable future.

This year, we are also deeply saddened and disturbed by the discovery of unmarked graves of Indigenous children on the grounds of former Residential Schools in Saskatchewan and across the nation. Our hearts go out to the families, survivors and to Indigenous communities. United Way Regina remains committed to finding ways to be strong allies of Indigenous peoples, recognize the intergenerational effects of residential schools, support educational equity and evolve our community investment approach in order to co-create our path forward.

Tackling intergenerational poverty by improving educational outcomes became even more critical. With school closures and restrictions in the classrooms, parents and caregivers had little choice but to become even more involved in their child's learning. For underserved children and their families, COVID worsened their situation significantly. Many families had inconsistent access to housing, food, and a reliable source of income.

In the midst of challenging times, there were so many bright spots. United Way Regina and our Education Sector partners successfully delivered on our Campaign for Grade Level Reading Plan. Over the course of three years, our plan aims to garner community-wide support to raise more than \$1.6 million to increase tools, resources and early literacy support for younger learners in twelve local Community Schools.

This year, we became the first United Way in Canada to offer VELLO - an innovative, 1:1 tutoring initiative used by many U.S.-based United Ways. VELLO unites students in local classrooms with adult role models who are passionate about helping kids to be all they can be. As well, United Way Regina became the lead for the

Regina and Region Family Literacy Hub, extending our reach and support to children and their families even before they begin school.

This Annual Report highlights only a few of the many heart-warming stories over the past year. Our sincerest thanks goes out to our donors and supporters who have truly made a difference. We are extremely grateful for your continued support.

Audit Committee Report

In 2020, the world abruptly changed when on March 11, the World Health Organization declared a global pandemic for the COVID-19 virus. Like no other time in recent history, all entities, whether government, for-profit business, educational institutions, non-profit organization or a charity, all had to pivot and abruptly change their way of doing business, their processes and the way they serve their stakeholders.

United Way Regina was no different. In 2021, United Way Regina sustained a focus on the ongoing need for continuous innovation, enhanced processes, reinvention and an elevated volunteer and donor experience. While doing so, the organization also stepped up as a partner to manage and distribute funds on behalf of the Government of Canada's Emergency Community Support Fund (ECSF) through two separate rounds of funding, ensuring immediate essential community services in Southern Saskatchewan continued during the pandemic.

Total revenues in the 2021 fiscal year for the primary Operating Fund were approximately \$4.37 million, compared to \$4.17 million in 2020, displaying our partners and donors ongoing commitment to show their local love in times of crisis, a large rebound on investment losses from the prior year, COVID-19 subsidies received, and rollout of delayed programming with associated revenues. Continued strategic and thoughtful spending resulted in the organization realizing a modest surplus to the Operating Fund of \$95,892. In addition to the primary Operating Fund, \$542,671

of designated revenue was received in our COVID-19 Response Fund, with the majority of these funds relating to federal government funding earmarked for distribution to other charities and NPOs.

Notable Community Impact investments for 2021 included almost \$1.5 million to funded partners, over \$1.6 million for COVID-19 response efforts (including \$1.5 million in Government of Canada's ECSF program distribution), \$233,508 to donations designated to other charities/agencies, and just over \$698,000 to 211 Saskatchewan. In addition, over \$1.24 million was invested in various Community Impact initiatives, both in staffing and programming expenses, to support signature initiatives related to improving third grade reading outcomes such as Summer Success and Campaign to Grade Level Reading, as well as volunteer engagement and non-profit sector support and assessment. Total Community Impact expenses amounted to almost \$3.7 million dollars out of Operating Fund & \$1.63 million out of the COVID-19 Response Fund in the 2020-21 fiscal year, supporting a variety of targeted community initiatives with a mandate to

mobilize collective action in United Way's three key focus areas, while also supporting vital services affected by the COVID-19 pandemic.

Total net assets at June 30, 2021 were calculated at approximately \$5.16 million, as compared to \$6.02 million the year prior, predominately mirroring several COVID-19 Response advances on funding received late in the previous fiscal year and expended in early this fiscal, less a modest year end surplus. During the year, the organization maintained the overarching benchmarks established in the Investment Policy, as well as the minimum and maximum internally-restricted reserves set forth in the Governance Policies. These outcomes signal considerable financial strength and adherence to risk-management guidelines.

As part of its mandate, the Audit Committee for United Way Regina conducted a full review of the 2021 Financial Statements, along with the controls over accounting and financial reporting, in consultation with Virtus Group LLP. The Committee is satisfied with the results of the audit review, inclusive of an in camera session with the auditors, and can assure all United Way Regina stakeholders that its resources are being managed both appropriately and effectively.

On behalf of the Board of Directors, it is my pleasure to present the United Way Regina's Summary Financial Statements report for the fiscal year ending June 30, 2021.





2020 Governance Committee Report

United Way Regina's Board is committed to ensuring it has the talent to provide strategic direction, ensuring necessary resources are in place to support this direction, and providing effective risk management and oversight for the organization. To fulfil its mandate, the Board tasks the Governance Committee with the responsibility to manage the Board Recruitment & Selection Process.

Beginning in February 2021, the Governance Committee launched an application process, seeking interested community leaders from United Way Regina's geographic responsibility area, which includes Regina, Moose Jaw, Swift Current and Weyburn. Information about the Board Selection & Recruitment process was shared through a variety of external channels.

After reviewing the Board's Skills Matrix, the Governance Committee designed the selection criteria and recruitment process. To address United Way Regina's identified skills gaps, the key competencies targeted individuals with financial competencies, including those with formal financial backgrounds and designations; legal; innovation, including strategic use of data and digital capabilities; and understanding of local philanthropy, including public, private and community leadership.
